English Learner Advisory Committee (ELAC) Minutes (DRAFT) May 21, 2020

- I. Welcome and Introduction** - Mrs. Watson welcomed those in attendance and introduced the members- everyone knew each other from previous meetings.
- II. Call the meeting to order.** The meeting was called to order at 10:36 A.M.
- III. Call for any additions/deletions of agenda items.**
Mrs. Watson called for any additions or deletions of agenda items from those in attendance. No one indicated they had any. Mrs. Watson asked that the LCAP be added to the agenda as a new item. Mrs. Webb motioned to accept this, and Mrs. Ctibor seconded the motion. Motion was accepted.

- V. Reading and approval of the minutes.** Mrs. Watson read the minutes from the previous meeting and asked if anyone would like to motion to approve the minutes. Mrs. Webb motioned to approve the minutes and Mrs. Gaytan seconded the motion. The minutes were approved.

Single Plan for Student Achievement/Review -Mrs. Watson explained that the committee would be reviewing the SPSA goals for the purpose of giving the SSC input. Mrs. Watson explained that the School Site Council is an advisory committee to the principal and is made up of the principal, teachers, support staff, and parents. The SSC is responsible for developing the school improvement plan, called the Single Plan for Student Achievement (SPSA). The SSC decides upon academic instructional programs and all related categorical resource expenditures for a school. She shared the SPSA goals proposed by the SSC. She began with goal 1.

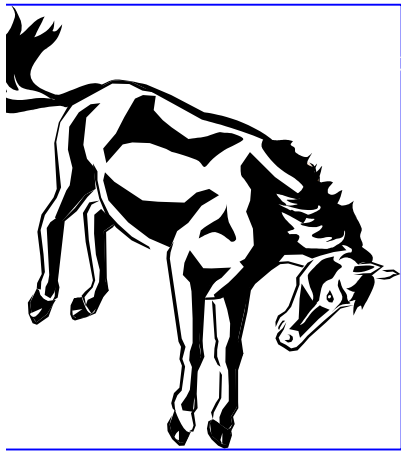
Language Census Report - Mrs. Watson reminded those present that there were still parts of the Language Census Report that needed to be reviewed. She explained that the language census includes sets of data sent to the California Department of Education (CDE) about English Language learners.

The report can be used to plan for future English learner programs and staffing. The report includes:

- Enrollment by English Language Acquisition Status (ELAS) and Grade
- “Ever-ELs” by Grade
- “At-Risk” and Long-Term English Learners (LTEL) by Grade
- “Ever-ELs” by Years as EL and Reclassification (RFEP) Status and Grade
- English Learners by Language and Grade
- Annual Reclassification (RFEP) Counts and Rates
- Language Group Data to Determine 15 percent and Above Translation Needs

Mrs. Watson then provided the annual data for Berenda Elementary for the 2019-20 school year reading directly from the downloaded report from the CDE website.

II Llame a la reunión al orden. - Se convocó la reunión a las 10:36 a.m.

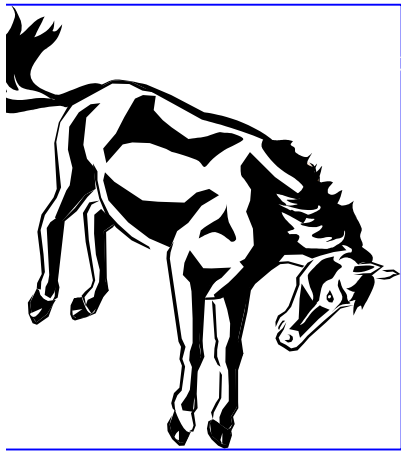
