We also talked about reclassification criteria for EL students.. How one becomes an EL. Went over the importance of attendance. We gave dates on the NWEA and other district assessments. Students testing going on right now. Talked about the importance of student attendance. Minutes approved.*

V. Department of Health - Evelyn Ramirez

..Ms. Ramirez is our school's lead person but she is feeling under the weather, so Ms. JoAnn presented the powerpoint for Public Health. They will be here during Open House. The Department of Public Health is able to support elementary and middle schools The grant is given to several schools and middle schools. They join with cal-fresh to support the other schools that public health does not cover.

Services to the schools:

--- stencils work. Paint is provided. Can do stencil touch-up. Volunteers help with the stencils. Several schools have already reached out. They can meet with what best works for the school. Traffic stencils also available.

---Providing safe routes to school. Walk to school. We partner with police dept and other agencies and provide guidance in the safest way to get to school. Look for possible sidewalks (assessments)

---Garden project we have letter donation letters to take to stores and get donations to implement gardens and connect with the highschool to help build the bed, fertilizer, etc... Garden can be seasonal.

---Smarter lunchroom with parent champions, assess the atmosphere of the cafeteria..Main goal the that all students have access to healthy meal choices.

---Employee week---we support a employee with events diabetes information, potluck recipes, smoothie day.

Encourage teachers to take care of themselves.

---Outreach events---they can come and support and provide information. Goodies available to the communities, ex. Recipe cards, cook books, etc...

---School Wellness goes through or aligns with the PE coach--- provide resources for physical activities.

New Business

A. Opt out of English Learner Programs -

English Language Development. How do I opt out of it? In elementary school it is not recommended . Usually in middle school. A parent guardian must submit a request.. You can not opt out of the ELPAC. It is a requirement.

---Parent Catalina- ask what other support can students earn to pass the ELPAC. Ms. Lack said--teachers are knowledgeable of where the students are. During staff meetings administration informs teachers how important it is to know where their students are in testing. This is why we are pushing writing and sentence frames so much.

Students are currently in the middle of the testing. If they are in level 3 our hope is that they will be reclassified. Teachers pull small groups and see where the child is struggling. There are 4 categories. We can touch bases with the teacher so we can help the child. Parent may leave info so they can provide further info.
