1. Call to order/Digital Norms / Robert's Rules of Order

The meeting was called to order at 4:00 pm. Due to the Chairperson, Ms. Somonte, not being present, the Co-/Chairperson, Mr. Avitia, facilitated the meeting with the assistance of Mr. Hollman. Mr. Avitia translated the meeting as it was presented for Ms. Hernandez.

Review of the Family School Compact / (Spanish)

There was a change on the last bullet of "The Student Pledge", discussed and agreed upon. A motion was made by Mr. Hollman to approve the change to the Family School Compact. A second was made by Ms. Mac Eacheron. Approval of the Family School compact was unanimous.

After School Update:

Ms. Barajas shared that the After School Program, (ASP) started today to all students that need academic support. Students participating can earn up to 8 elective credits. The ASP is available virtually, Monday through Friday, from 3:00 pm to 6:00 pm. All students have been invited to attend.

Review of the Parent Involvement Policy / (Spanish)
