





Plan Summary 2022-23

General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten–12, as applicable to the LEA.

Established in 2005 and named after a pioneering Latino leader in the Central Valley, Ezequiel Tafoya Alvarado Academy (ETTA) is proud of our heritage and distinctive educational emphasis. We are a TK-8 independent public charter school located in Madera. The tagline for Ezequiel Tafoya Alvarado Academy is "a school for smart kids." And this impetus fuels the ETAA's focus on empowering economically underprivileged Latino children in Madera, through education. These efforts are intended to breed future leaders in the state's extremely large Latino community, where children often attend underserved public schools. Ezequiel Tafoya Alvarado Academy (ETAA) began its 16th year of operation in 2020-2021. The community of Madera, which is over 80% Latino has been a huge supporter of ETAA. We have become a recognized institution in the city and our enrollment is a measure of that success.

The school began with 167 students and in 2020-21 served approximately 604 students in Transitional Kindergarten through the 8th grade: approximately 572 (94.4%) students qualify for Free or Reduced Lunch; 240 (39.7%) students are English Learners; and 139 (23%) students are Re-designated Fluent English Proficient. In addition, about 40 (6.6%) students qualify for special education services. The LCFF Unduplicated percentage is approximately 91.53%. Approximately, 96.7% of ETTA's s students identify as being Hispanic or Latino, 1.5% as white.

The purpose of this Local Control Accountability Plan (LCAP) is to address the School Plan for Student Achievement (SPSA) for Ezequiel Tafoya Alvarado Academy which is the Schoolwide Program; herein referred to as the LCAP. The Charter School's plan is to effectively meet the ESSA Requirements in alignment with the LCAP and other federal, state and local programs. The plans included in the LCAP address these requirements compliant to include focusing on three goals: ETAA will create a high-quality teaching and learning environment that will allow all students to become scholars; ETAA will foster a welcoming and safe school environment; ETAA will fully engage families and the larger community in support of short and long-term educational outcomes. The Charter School completed a comprehensive needs assessment of the entire school which included an analysis of verifiable state data and local performance data used to measure student outcomes as evidenced in the annual update portion of the LCAP. The needs assessment process included meeting parents, classified staff,

teachers and administrators to identify areas of opportunity for the students and groups of students who are not achieving standard mastery and to identify strategies which will be implemented in the LCAP to address those areas of opportunity.

The identification of the process for evaluating and monitoring the implementation of the LCAP and the progress toward accomplishing the established goals will include discussing the actions and services with the use of supplemental funds at the school level through the Parent Advisory Council which will include parents of English Learners. The Parent Advisory Council will meet four times per year to inform the process. Parents, classified staff, certificated staff and an administrator will make up the council. The number of parents will exceed or be equal to the number of total staff members. The council will discuss academic performance, supplemental services and areas to make improvements with Title funds as part of the School Plan included in the LCAP conversations at the meeting in the fall and at the meeting in the spring. The teachers, staff, students and parents also participate in an annual survey which provides feedback on the goals and services. The teachers, staff and administrators actively participate in the decision making process throughout the year and during LCAP workshops. The decisions will take into account the needs of Ezequiel Tafoya Alvarado Academy based on student achievement data to include SBAC, ELPAC, and interim assessment data, cumulative assessments, and attendance and student demographic data to include the significant subgroups of Latino, Black or African American, White, socioeconomically disadvantaged, students with disabilities, and English Learners. This student achievement data and student demographic data will be used as a basis for making decisions about the use of supplemental federal funds and the development of policies on basic core services.

Each goal includes actions and services that address the needs of all students and significant subgroups which include evidence-based strategies that provide opportunities for all children, methods and instructional strategies, and particular focus on students at risk of not meeting the State academic standards.

Reflections: Successes

A description of successes and/or progress based on a review of the California School Dashboard (Dashboard) and local data.

This plan was developed during the COVID-19 pandemic which caused school closures and disrupted state testing and local assessment activities. We therefore have less data available to measure and celebrate progress by.

We are immensely proud of our staff, students, and families, who all worked together to respond and adapt to the circumstances of the pandemic in order to return to our full in-person instructional program adjusted to meet the increased needs of our students. We are proud of the consistent stakeholder engagement and close collaboration achieved by our parents and staff in providing critical feedback and contributing to the ongoing planning required throughout the past year and prior year. The return to our regular schedule has also allowed us to return to providing school activities, food service, and field trips. We have been recognized by the state of California for Platinum recognition for strong implementation of the PBIS program. 98% of our students have had 1 or fewer Office Discipline referrals this year and no students have six or more. Our family engagement, family communication, and family education efforts have succeeded in helping families feel comfortable sending their children back to school for in-person instruction and participating in family engagement events. We achieved improved attendance as this school year has progressed with an overall average daily attendance rate of 93.49% which is lower

than pre-pandemic attendance rate, but still a success due to the challenges to student attendance this year. Many of the family engagement practices we have utilized during the pandemic will be continued in the future. The satisfaction of our families is evident in increased student attendance rates and high enrollment rates while other schools in our areas are struggling with declining enrollment. Students and families are happy with our school and are telling others about it.

Reflections: Identified Need

A description of any areas that need significant improvement based on a review of Dashboard and local data, including any areas of low performance and significant performance gaps among student groups on Dashboard indicators, and any steps taken to address those areas.

The 2021 CA Dashboard was not produced due to lack of data in the midst of the pandemic, and therefore we are unable to identify needs related to those state indicators. Based on local data and 2019 CA School Dashboard data, we have identified needs in ELA and Math achievement. We are beginning to see progress building on the baseline data from the beginning of the year in Reading and Math but there is much work to be done to address the learning loss that has occurred during the pandemic. We will implement standards-based instruction in ELA and Math and utilize assessments to monitor progress and differentiate instruction and intervention. We will also provide additional professional development to support staff in content/curriculum implementation.

We also have identified needs in student emotional regulation and social skills and will continue to provide staff and classroom activities to support the development of these skills.

There is also a growing need for additional space to alleviate crowding for staff and students and allow more separation between the elementary and middle school students.

The 2021-24 LCAP provides our three-year plan for continued improvement and development. In 2022-23 we will continue the specific actions undertaken to address the varied academic and social-emotional needs of our students.

GOAL 1: ETAA will create a high-quality teaching and learning environment that will allow all students to become scholars. In terms of student achievement (Goal 1), we will continue providing a comprehensive standards-aligned instructional program in conjunction with a comprehensive assessment system. We will use the results of assessments to differentiate instruction within classrooms and to inform our system of intervention. We will provide systemic English Language Development for our English learners and a comprehensive SPED program for our students with IEPs. ETAA teachers will be supported through professional development to implement our curriculum and instructional model, including specific support for new teachers and a comprehensive system of teacher observation and coaching.

GOAL 2: ETAA will foster a welcoming and safe school environment. In terms of our work to maintain a positive culture and climate (Goal 2), students are supported in Social Emotional Learning as well as supportive practices in behavior, attendance, and student activities as well as a clean and safe environment. We implement school spirit traditions and student activities, as well as a comprehensive Positive Behavior Supports and Intervention program schoolwide. We incorporate mental health supports and supports for Foster Youth and Homeless students into our program as well.

GOAL 3: ETAA will fully engage families and the larger community in support of short and long-term educational outcomes. Families will be supported to participate actively in the life of the school and their child's education through frequent workshops, trainings, and opportunities for input. These opportunities include parent teacher conferences, Back to School Night, workshops on how to support children academically and with mental health and wellness, and our annual Art Walk.

Ezequiel Tafoya Alvarado Academy has a long-established foundational principle of meaningful educational partner engagement. These efforts were refined and improved through the Local Control and Accountability Plan (LCAP) development process. The school's practices have been further enhanced during the pandemic as the school sought the input and feedback of its educational partner groups from the onset of the pandemic and continuing through the development of the Learning Continuity and Attendance Plan, the 2021-2022 LCAP, Expanded Learning Opportunities Grant and the ESSER III Expenditure Plan.

- The School Site Council is composed of parents and staff. The SSC and District English Learner Advisory Council (DELAC) met quarterly throughout the year to reflect on data and provide input on plan development. We also held one meeting attended by staff and parents for input on our Title I plan. Our board meets monthly as a public hearing with the opportunity for public comment. We promoted parent participation in public meetings and public hearings through our website and agenda posting. Virtual meetings conducted via video conference had telephone call-in access. We provided translation as needed. The SSC reviewed the LCAP on April 19, 2022 and the DELAC reviewed the April 21,2022. The LCAP public hearing was held on May 12, 2022 and the Board approved the LCAP on June 16, 2022.
- Parents are also encouraged to communicate via email, phone call, or in-person meeting with the administration as well as communication on ClassDojo. Prior to the development of the LCAP, the parents completed a School Climate Survey to address specific needs.
- Teachers provide feedback during weekly leadership meetings for grade level lead teachers and other staff. The teachers also have weekly opportunities to collaborate as a full staff and weekly opportunities to collaborate with specifically their grade level. Prior to the development of the LCAP, the staff completed a School Climate Survey to address specific needs.
- The administration communicates daily with students in the classroom or playground to garner input. The teachers also collaborate with the students and share their input during weekly leadership meetings. Prior to the development of the LCAP, the students completed a School Climate Survey to address specific needs.

We look forward to being able to expand the professional development to our after school program and create a seamless day to afterschool system to support Goal 1. We look forward to adding staff and building a team to

enrich our physical site and environment to include an expanded playground and more events like a talent show for students and families and workshops for parents in support of Goals 2 and 3.

We have increased our professional development budget to offer more training opportunities to all staff.

Goal Analysis for 2021-22

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

All actions were implemented as planned except we weren't able to provide a reading intervention teacher to support student reading needs in grades 6-8 because the needs were so great in the lower grades after so much time in distance learning.

Successes: ELD Program was quite successful with full professional development for teachers and support, ELPAC testing completed, and materials and resources supplied. We were able to boost our redesignated rate (awaiting results) due to the supports implemented this year.

Challenges: The teachers need more training to support curriculum implementation. Adopting a new Social Studies curriculum has taken a lot of time this year. We weren't able to provide a reading intervention teacher to support student reading needs in grades 6-8 because the needs were so great in the lower grades after so much time in distance learning.

The differences

An explanation of how effective the specific actions were in making progress toward the goal.

The SSC and DELAC identified the following as successful components of Goal 1 actions this year: Continuous Professional Development, ELD Professional Development, Paraprofessionals, Low Student to teacher ratio, After School Tutoring and Summer school. The following components were identified by the SSC and DELAC as needs: ASES training & collaboration with classroom teachers and Paraprofessionals in the upper grades.

Professional development has been successful at ensuring Full Implementation and Sustainability around implementation of all CA adopted content standards, including ELD standards. Standards-aligned instruction materials and curriculum has successfully ensured all students have access to standards-aligned instructional materials for use at home and at school. Assessments have been successful at providing the data to identify students for additional academic support. The evidence for the effectiveness of the Academic Support action is so far unclear with limited data returning from distance learning, however we know that the action would be more effective if we were able to provide the same level of supports to our upper grade students. The English Learner support and services action has been effective based on anecdotal data and we expect to have official data to support this analysis next year. The Special Education action has been effective at ensuring students have access to all required services and next year we hope to have CAASPP data to use as a baseline for determining the

effectiveness of this action in increasing academic achievement next year. The library action has ensured our students have opportunities and books available for reading at school and at home.

No changes have been made to the planned goal, desired outcomes, or actions for the coming year that resulted from reflections on prior practice. The metric "degree of implementation of all CA adopted content standards, including ELD standards" was added to ensure compliance with CDE LCAP guidance.

All actions have been implemented as planned.

Successes: Students and families are happy to have returned to regular in-person instruction this year with a positive, enriching environment. We have successfully implemented the school wide behavior matrix. We are proud to be a California PBIS Platinum recipient for the work we have done implementing a high-quality PBIS program. We have been able to successfully expand our counseling team and implement our attendance monitoring procedures.

Challenges: This has been a very difficult year for the students with many of them experiencing anxiety and fear this year, and as a result of this and the lack of social interaction for a long period of time, we are seeing an increase in poor social skills. This has created an overwhelming

amount of needs to be addressed by the counselors and staff. 241 of our 604 students were seen by our 2 full-time counselors and 1 intern during the month of March.

The safe, clean facilities action has been effective as evidenced by an overall facilities rating of "Good" on facilities inspections. The Mental Health/Social Emotional Learning, PBIS, Student Activities, and Student Supports actions have been effective as evidenced by the low suspension and expulsion rates, high percentages of parents, students, and teachers with positive response regarding school safety and school connectedness, a high re-enrollment rate, and a 0% middle school dropout rate.

The effectiveness of the Attendance Initiatives is evidenced by a 93.49% average daily attendance rate, which is lower than the average pre-pandemic, but we consider a success with all of the challenges to student attendance during the pandemic. The average attendance rate started out low and has been increasing since February to approximately 97%.

Overall, the actions were implemented as planned. We have been able to hold a handful of our regular family events this year, but due to the pandemic, we weren't able to hold all of them. We've had between 4-8 families attending evening parenting classes that provide information for

parents to support social emotional development at home. We have partnered with local agencies to provide support for families and students in need of more intensive supports.

Successes: Our families have been happy that school was back in session and they have attended our family events at a high rate this year. We had an 89% attendance rate for parent conferences.

Challenges: A lot of our parents have experienced unprecedented challenges during the pandemic and have their own emotional needs that have not yet been addressed. This has created challenges for our school staff to support these parents this year.

A- Academic Growth and Achievement

Needs, Conditions, Circumstances

In reviewing the 2019 ELA and Math performance of our English Learners and Socioeconomically Disadvantaged students, we find that both groups are at Orange level for ELA and Math. We had Level 3 performance in 2019 on the English Learner Progress Indicator, with 49.7 % of students making progress towards English language proficiency. In 2021, the English Learner Progress Indicator was not produced by the CDE. On the ELPAC 41.7% of our English Learners scored at Levels 3 or 4, with 6.5% scoring at Level 4 (Proficient). In 2020-21, the English Learner reclassification rate decreased dramatically to 2.1%

Actions

Based on a review of data, we have designed the 21-24 LCAP to implement strategies that effectively address learning gaps where needed while promoting rigorous grade level instruction. We have planned for extensive professional development in support of our goals. We have selected a variety of curricular and instructional resources, supported by appropriate technology, that allow students to learn and practice both at grade level and with personalized content to fill gaps and advance skills. This is coupled with a comprehensive assessment system that monitors student progress towards meeting grade level standards and informs our comprehensive system of academic support. The academic support begins with smaller class sizes to ensure additional students support and expands to includes credentialed reading intervention teachers for each grade band (K-3 and 4-8) for those students who need additional support. We have also created a designated space to be our school librarian, staffed with a full-time librarian and ~10,000 physical and digital books available for students to check out. We have also designed a comprehensive program of English Language Development to ensure that our English Learners become proficient and are able to reclassify at high rates.

Expected Outcomes

By implementing the identified actions, we will ensure steady growth in our academic outcomes, such as SBAC ELA and Math, English Learner Progress, Reclassification rates. Current targets aim for at least approximately 16 points growth within the next three years for both ELA and Math (see expected outcomes in Goal 1),, and 5 points' growth in the English Learner Progress Indicator and to increase our reclassification rate. We plan to use interim assessment data to gauge progress throughout the year.

B- Climate and Culture

Needs, Conditions, Circumstances

In 2019, our Socioeconomically disadvantaged students and our English Learners had a suspension rate in the Blue level. Our Chronic Absence rate was in the Yellow level for both groups, but remained at 5% or lower. In 2020-21, 92% of parents indicated that they feel their child is safe at school.

Actions

Based on the data, we see positive signs of the impact of our efforts to foster a positive culture and climate in support of students both holistically and academically. Key components of these additional efforts include providing Social Emotional Learning opportunities and mental health support to support the well-being of our students and remove additional barriers to learning and engagement. We have added extensive training in Positive Behavior Intervention Supports (PBIS). We also provide student activities such as sports and enrichment opportunities which foster belonging, develop the whole child, and promote attendance and investment. We provide specific supports for our Foster Youth and Homeless students through our Liaison and our SST process.

Ezequiel Tafoya Alvarado Academy is a single-site LEA with an enrollment of unduplicated student groups greater than 55%. The school is using the additional concentration grant add-on funding it received to increase the number of staff who provide direct services to students by hiring an additional reading intervention teacher to provide reading instruction to students. The additional funding also allowed the school to

retain the existing reading intervention teachers who provide direct reading instruction services to students. The additional funding has allowed us to not only maintain our low student to staff ratio, but to decrease it even further to better support our students after returning to full in-person instruction.

The Local Control Funding Formula (LCFF) requires local educational agencies (LEAs) to engage their local educational partners in an annual planning process to evaluate their progress within eight state priority areas encompassing all statutory metrics (COEs have 10 state priorities). LEAs document the results of this planning process in the LCAP using the template adopted by the State Board of Education.

The LCAP development process serves three distinct, but related functions:

- Comprehensive Strategic Planning: The process of developing and annually updating the LCAP supports comprehensive strategic planning (California *Education Code* [*EC*] Section 52064[e][1]). Strategic planning that is comprehensive connects budgetary decisions to teaching and learning performance data.
