## Madera South High School Dance Guest Pass Application Procedures and Guidelines 2019-2020

## **Application Procedures:**

- 1. Students purchasing tickets must have a MSHS School ID. ID's will be scanned to verify that students are not on LOP.
- 2. The guest must obtain approval/signature from their home office administrator and attach a copy of their school ID.
  - a. If they are out of high school, they must attach a copy of their driver's license.
- 3. The MSHS student must complete the application and return it to their home office for administrative approval. Once the guest has administrative approval the MSHS student will turn in their guest pass application when they purchase tickets. Guests will be verified upon entry to the dance. Please be aware that approval may not be immediate and may take up to a couple of days for approval. Please plan accordingly.
- 4. Students must not be on LOP at the time of purchase. If you are on LOP for any reason at the time of purchase you will not be allowed to purchase tickets.

## **Guest Policies:**

- 1. Each MSHS student is limited to one guest per dance.
- 2. The use of a dance guest pass is a privilege, not a right.
- 3. Abuse of the Dance Guest Pass will result in the MSHS student losing the privilege of using the guest pass for future dances.
- 4. Do not apply for a Dance Guest Pass Application if you plan to attend the dance alone. It is required that you walk in with your guest.
- 5. A guest must be at least enrolled in the 9th grade, and cannot exceed 20 years of age.
- 6. All guests must present a picture ID that matches the copies attached to the Guest Pass Application at the door, and have it available all night, upon request.
- 7. For any violation of school rules, the MSHS student's parent will be contacted to pick up the MSHS student and guest. Any party under the influence of drugs or alcohol, the parent will be contacted and requested to pick up the MSHS student and guest. If unable to make parent contract, the MSHS student and guest will be turned over to the police. The MSHS student, upon return to school, will be suspended and the guest's school will be notified.
