AGENDA ITEMS

1. Welcome - Establish A Quorum

Ms. Munoz welcomed all in attendance. Quorum established.

2. Call to Order

Meeting called to order at 3:33 pm

3. Adoption of the Agenda: Add or Deletion of the Agenda (motion needed)

Agenda for 2/12/20 was reviewed. No additions or deletions for the agenda. Jessica Salinas motioned to adopt the agenda. Vanessa Madrigales seconded the motion. 7 ayes, 0 nays; motion carried.

4. Public Input

5. Approval of Previous Minutes – November 13, 2019 (motion needed)

Minutes from the meeting on 11/13/19 reviewed. No questions or comments. Martha Galindo motioned to approve the minutes. Vanessa Madrigales seconded the motion. 7 ayes, 0 nays; motion carried.

6. New Business

a. 2020 Safe School Plan (motion needed)

Mrs. Derkalousdian gave an overview of the Safe School Plan. Plan contains information regarding emergency procedures, monthly practice drills, and evacuation plans. Mrs. Derkalousdian opened the floor for questions or comments. Vanessa Madrigales asked what type of lockdown drills are practiced at Parkwood. Ms. Munoz explained there are three lockdown levels and reviewed each one briefly. She explained all MUSD schools operate on a Level 1 and our first practice lockdown drill was at a Level 2. Ms. Munoz explained the next lockdown drill would be at a Level 3. Arhea Adams stated she heard schools would potentially not have practice lockdown drills due to the traumatic effects it could have on children.

Martha Galindo stated she heard the same. Ms. Munoz explained if anything changes, schools would likely be notified. Mrs. Derkalousdian asked for a motion to approve the Safety Plan. Arhea Adams motioned to approve the Safety Plan. Martha Galindo seconded the motion. 7 ayes, 0 nays; motion carried.

7. Reports

a. Second Quarter Progress Report on the SPSA

Ms. Munoz gave an update on quarter 2 spending. Each grade level received \$1500 to spend on items to supplement the curriculum. Each grade level ordered items specific to their needs. Also, each teacher received \$400 to purchase classroom library books. Class sets of headphones will be ordered for 4th grade to phase out earbuds which 4th grade previously received. If money is still available, headphones will be ordered for 5th grade.

b. Professional Development

Ms. Munoz explained teachers are participating in ongoing professional development to strengthen their teaching practices. Teachers have received professional development in ELA and Math utilizing coaching cycles. Ms. Munoz explained the coaching cycle process and how it has impacted teacher practices, thus impacting student achievement. Martha Galindo shared her experience with coaching cycles and how she is growing as a teacher through this process.

c. English Language Proficiency Assessment for California (ELPAC)

Mrs. Derkalousdian gave an overview of the ELPAC assessment. She shared several updates. Students must score a Level 4 to be considered for reclassification. The ELPAC assessment consists of four domains: listening, speaking, reading, and writing. For grades 3-6, the assessment will be all digital. Grades K-1 will still take the paper-pencil assessment with the ELPAC team. The speaking portion for grades K-6 will be administered by the district team. Grade 2 will take the writing portion with the classroom teacher and the rest with the ELPAC team. Grades 3-6 will take the assessment in March and grades K-3 in May.
