#### 11A. STANDARDS REPORT

Kathy Lopes presented a PowerPoint report on the drop out rate for 2007/08. This is a new report we will be receiving from the state each May covering the previous school year.

President Westley emphasized the need to understand the reasons for drop outs and then addressing those reasons. Ms. Lopes explained the state is developing a numbering system for identifying students that will be used throughout the state and will assist in monitoring mobility. Additional clarifying questions and comments were made.

Janet Grossnicklaus presented reports on State and Similar School Rankings that were just released.

#### 11B. BUSINESS AND OPERATIONS UPDATE

Kelly Porterfield presented an update on developing a preliminary budget which will be brought to the June 9<sup>th</sup> board meeting with the adopted budget to follow at the 2<sup>nd</sup> board meeting in June.

Mr. Porterfield also addressed the Memorandum of Understanding between Madera Unified and CSEA approved earlier this evening (Item 10C above) for a 10-day furlough and indicated we should be able to buy back 5 of those days. This will be brought to the board for approval. CMBA and confidential employees will also take a 5-day furlough rather than a 2.5% pay reduction.

President Westley asked about scheduling a Budget and Finance Committee meeting. Mr. Porterfield responded they hope to have a meeting between presenting the preliminary budget and adoption of the budget.
