Kathleen Lopes presented a PowerPoint overview of AGB activities in 2008/09 and their recommendations for the four Program Improvement schools they monitor. Overall recommendations, in addition to individual recommendations for Madison Elementary, Millview Elementary, Washington Elementary and Martin Luther King Middle School were presented.

Following Ms. Lopes presentation the Board questioned the effectiveness of recommendations made by the AG Board. Ms. Lopes responded with comments on a site-by-site basis. The Board stated their concerns with the lack of progress at Martin Luther King Middle School. Ms. Lopes responded that some staffing

changes have been made over the past few years and talked about the evolving role of academic coaches. Ms. Lopes added that AGB can only make certain recommendations. Anything beyond that would need to come from the Board of Trustees. The Board discussed the fact that approximately 60% of the current teaching staff have been at that site for only 2-3 years. Another serious concern is the fact that students move into 7th grade at Martin Luther King with good grades and their GPA declines by the end of 8th grade. The Board discussed the need for changes in administration at Martin Luther King. Another option is "reconstitution" of the school. Ms. Lopes explained the process as completely starting over with staff – everyone currently employed at that site would be required to re-apply for their positions. Additional discussion included the lack of good teaching; the amount of training invested in the staff; monitoring use of training. MLK is also a QEIA funded school that requires staffing of 25/1. The importance of providing encouragement to students; providing an environment conducive to doing homework and the involvement of parents in the school was discussed. It was suggested that a "homework policy" be instituted and we should have the expectation that teachers assign worthy work. Any further discussions regarding staffing will be undertaken by the Board and/or staff.
