7. COMMUNICATIONS

7A. PUBLIC HEARING

President Seibert opened the meeting for visitors to speak on a subject not on the Board Agenda.

Virginia Foster Chadwick, Ph.D., Professor of Kinesiology at California State University, Fresno addressed the Board regarding keeping the P.E. Specialists at Madera Unified School District. She said that employers want workers strong enough to do the job, and strengh comes from students who have P.E. every day. She also said that the health benefits of physical education are reason enough to provide quality physical education to our children.

Tim Hamel, P.E. Options Coordinator, California State University Fresno addressed the Board representing the P.E. Specialists and John Denno of Madera Unified School District. Mr. Hamel referred to our Mission Statement which states that children should not be bound by their circumstances. He said that the budget cuts are a circumstance that will affect the children in Madera Unified. He read several letters from 4th and 5th grade students at Alpha School titled "What P.E. Means to Me". He asked the Board to consider the children before making the final budget cuts, specially cutting P.E. Specialists.

Julie Franich, 645 East Champlain, Fresno, California, School Nurse for MUSD addressed the Board regarding taking 10 days away from school nurses for budget reasons. She asked the Board to reconsider taking the 10 days away, and to consider all of the work that they do with the Special needs children, etc.

Tina Gonzalez, 17387 El Paso Road, Madera, California, School Nurse for MUSD addressed the Board regarding taking 10 days away from school nurses for budget reasons. She said that the nurses get kids moving. She also said that the nurse's work many days before school starts, and after school is out. She asked the Board to reconsider taking the 10 days away. She also gave the Board a hand out of the Bargaining Agreement between MUTA and MUSD showing the amount of days to be worked by school nurses.

Mauricio Sanchez, 25823 Roxbury Drive, Madera, California is a custodian at Ripperdan High school. He said that his job is being cut. He asked what he should do to keep his job because he needs this job. Superintendent Risinger asked Mr. Stehman, Director of Human Resources to contact Mr. Sanchez.

Kelly Valmonte, 5848 West Menlo Avenue, Fresno, California teaches P.E. at Madera South High School, and she was pink slipped this year. She said that P.E. is for kids and children need P.E. at a young age. She asked the Board to reconsider cutting her position.

She stated that she has had the same students for 3 years, and these students rely on her. She also said that the P.E. Specialists help students stay on top of obesity, diabetes, and they teach the children about proper nutrition. She asked the Board to please reconsider cutting the P.E. Specialists.

Trustee Adams stated that he had attended the Madera South High School presentation "The Baker's Wife", and said that it outstanding job well done by our High School students. It involves ROP, instrumental and choral students.

13. MISCELLANEOUS

Trustee Goodwin said that she visited the Weight Room at Madera High School and she observed that there was no cleaning station for the weight equipment. She asked the students how the equipment was cleaned and the students replied that they use their shirts. Trustee Goodwin would like to have a printed cleaning protocol available at all of the stations, and make sure that it is implemented. Her concern is that Methicillin resistant *Staphylococcus aureus* (MRSA) is showing up in High Schools around the country. This is a "staph" bacteria that is resistant to penicillin as well as some other common antibiotics. MRSA commonly causes skin infections that may look like spider bites, infected turf burns, impetigo, boils or abscesses. It is spread by touching the infection/drainage or by touching surfaces that have come in contact with the infection/drainage. MRSA can stay on surfaces for weeks.

She also observed the Madera High School swim team and noticed many were sunburned. She would like to see them use sun screen.
