6A. PUBLIC HEARING

President Seibert opened the meeting for visitors to speak on a subject not on the Board Agenda.

Marissa Saldate, 309 Hilton, Madera, California, teacher at John Adams School, addressed the Board regarding the reassignment of classroom aides. She teaches the Districts first and only class for the Autistic. She said that her heart and passion is for the Autistic child, and her Autistic students in her classroom. She also said that she will make a model program out of her classroom. She said that Autistic children thrive on consistency. She said that consistency in the classroom is how an Autistic child grows. By reassigning classroom aides that Ms. Saldate has specifically trained for her program will only hurt the quality of the program, but she said that it will also hurt the students. She said that her students will experience great behavioral setbacks, which will then turn toward their academics. She said that time is of the essence with these children. Early and intense intervention by trained personnel is critical for their growth. To start a new school year with three new staff members who have never stepped foot in an Autism program is too much to ask of their parents who have endured this long journey, desperately seeking an educational program that meets the needs of their children. In conclusion, Ms. Saldate asked the Board for support. Support to create a program that these children deserve. Support for a program that has highly qualified staff that will not change from month to month or year to year. Support for a program that provides these children with an educational and behavioral intervention they deserve. Support for a program that prides itself on consistency and a program with integrity. And most important of all, a program that gives these children a voice. Ms. Saldate then introduced the staff that she works with: Ana Morfin, Instructional Aide; Denise Chambers, Instructional Aide; Villanueva, parent and Mrs. Hook, grandparent.

6B. STUDENT AND STAFF RECOGNITION

> Joe Trevino, Teach One to Lead One

Joe Trevino, of Teach One to Lead One gave a brief presentation and overview of the Teach One to Lead One program. The program has been in Madera for the last eight years. The program reaches thirteen different groups of students on three campuses. The campuses are Ripperdan, Mt. Vista and Madera High School, with over 300 students each week. New this year to the program is the Freshman Academy. It has grown tremendously through the year. Mr. Trevino said that he was skeptical about the Freshman Academy when it first started, but it has turned out to be a great program. He said that once a week they go into a classroom, and take over the classroom. They introduce a principle, such as self-control. Teach One to Lead One is based on principles instead of issues. Mr. Trevino said that they do not talk about drugs, accidents or gangs. They talk about self-control and how we have to have the strength and discipline to do what we need to do in certain situations to achieve our goals. That covers a broad range of things, he said. A big portion of the program is about their Volunteer Mentors, and forming relationships with these students. He said that the program and mentors try to be a constant in their lives, which often is the only constant in their lives. Mr. Trevino then explained to the Board that he had planned on having two sisters who participate in the program attend the Board meeting. Because of their troubled home life, they were not able to be at the meeting. He said that this again is an example of the students that they deal with every day. Trevino then introduced several of his staff that were present: Mel and Penny Cellini, Volunteer Mentors; Robert Poythress, Volunteer Mentor; Dennis Smith, Volunteer Mentor; Carey Pitman, English Teacher at Mt. Vista High School; and Steve Williams, Board Member, Celebrate Life International, parent company of Teach One to Lead One.

In Mid-May, Governor Schwarzenegger publicly issued a revision to the state's proposed budget, and the news was much better for K-12 education. At the May 27th Board meeting, the MUSD Board announced the reinstatement of 28 positions initially slated for elimination due to a budget shortfall. Tonight the Board announced more reinstatements. The items initially planned for elimination/reduction that will be restored are as follows:

- Nurses on 193-day contracts will not have their work days reduced to 183. Point of Clarification contract is for 188 work days.
- High school athletics budgets will not be reduced by 10%
- ➤ Middle school athletics budgets will not be reduced by 10%
- > The work experience program will not be eliminated
- ➤ The facilities planning analyst position and construction project coordinator position will be combined into one position. Both were
