CHANGES TO CONTRACT FORMS:

AD1-CCF01 Refer to Specification Section 00500, CONTRACT:

1. Refer to ARTICLE 4. LIQUIDATED DAMAGES and revise as shown below.

ARTICLE 4. LIQUIDATED DAMAGES. The Contractor acknowledges that the District will sustain actual damages for each and every day completion of the Project is delayed beyond the Contract Time. Because of the nature of the Project, it would be impracticable or extremely difficult to determine the District's actual damages. Accordingly, as provided in Government Code section 53069.85, it is agreed that the Contractor will pay the District the sum of \$1,500.00 for each and every calendar day of delay in completing the Work beyond the time prescribed in the Contract Documents for finishing the Work, as Liquidated Damages and not as a penalty or forfeiture. In the event the Liquidated Damages are not paid, the Contractor agrees the District

CHANGES TO CONDITIONS OF THE CONTRACT:

AD1-CCC01 Refer to Specification Section 0800, SPECIAL CONDITIONS:

- 1. Refer to Paragraph E. Contractor Coordination and revise as shown below.
- **E.** Contractor Coordination. District will furnish and install the portable building structure and Fire Tank through a separate contract. The General Contractor performing the work of Bid 031623 shall be responsible for coordinating their work with the portable building Contractor and Tank supplier and for ensuring the site is ready for the installation of the building and Tank prior to their arrival. The contractor is responsible for all the piping, fixtures, fitting, valves, and other items as indicated in the contract documents to integrate the new tank into the fire tank infrastructure so as to provide a fully operational system. The portable building is scheduled to arrive on-site no later than June 12, 2023. The concrete foundation shall have a minimum of seven (7) calendar days of cure time prior to this date.

AD1-CCC02 Refer to Specification Section 0800, SPECIAL CONDITIONS:

- 1. Refer to added Paragraph G. Weather Bank as shown below.
- G. Weather Bank. Contractor shall include a weather bank of three working days on the critical path of the schedule.

AD1-CCC03 Refer to Specification Section 0800, SPECIAL CONDITIONS:

- 1. Refer to added Paragraph H. Punchlist as shown below.
- H. Punchlist. Punchlist activities (those that are not required to complete the project per plans/specs, and do not affect occupancy or the District's ability to load and/or use the facility for its intended purpose) may be completed up to 10 calendar days after the original contract completion date. Contractor shall provide the Architect a minimum of 72 hour notice to perform the punch walk, and allow an additional three working days for Architect to draft and distribute the punchlist. All punchlist work which takes place after the Original Contract completion date must be performed after school hours and/or during weekends. Contractor shall include any/all related costs (including overtime) in their bid proposal.




