Question regarding Add Alt.Clarification:

This is not on sheet MS. DD Alternate: Provide & install all materials and perform all labor necessary to complete the following: Install a Kidde ECS-500 Novec 1230 Fire Suppression System to protect the Data Room (2883 CUT Ft.) with a 4.7% concentration of Novec 1230. The ceiling height of the data room shall be 8'0". The system is designed to provide a main supply of Novec 1230 only. The Novec 1230 control panel shall be installed in the server room. The Novec 1230 cylinder shall be installed in the adjacent records room mezzanine. The room as one (1) exit/entry door that leads into the interior of another room, (does not lead to the outside) The cylinder is a 200 lb. tank with a 12.775 In diameter. See attached cylinder specification sheet. See specification for additional information.
