DRAWINGS:

Item 2-01 – Sheet M0.2:

Air Distribution Schedule: Symbol G shall be changed to the following: Fixed louvered face diffuser, aluminum construction. Titus model TDC-1.

Item 2-02 – Sheet M2.1: A. Symbol G diffusers shall be changed to 48”x12”-4 size and the 36”x9” duct drops thru roof in keynote 4 shall be revised to 48”x9” with transition at ceiling grille.

Pre-Bid Questions and Clarifications

1. Is the existing gym floor concrete or wood framing?

Response: Concrete

2. Is there a specific method for gym floor protection required?

Response: No, the contractor controls its means and methods

3. Have the ceiling tiles and glue in the wrestling room been tested for asbestos?

Response: No. The District will have them surveyed. The District will be responsible for abatement if asbestos is found.

4. What is the ceiling finish material in the gym?

Response: The ceiling appears to be acoustic gyp board.

5. **The roofing detail (Sheet E3.2 / Detail 2) illustrates laying the B-22 channel directly on the roofing. On the job walk, I noticed that the existing conditions were utilizing roof blocks. Please advise.**

Response: The use of Cooper B-Line DB Series roof supports is acceptable for intermediate supports. Supports at equipment, change of direction, and every 20'-0" shall be per approved plans
