Denisse Frayre, Student Board Representative, Madera South High School and Karamjot Kaur, Student Board Representative, Madera High School each presented highlights of activities taking place at their respective school sites.

7. <u>Communications</u>

7A. Public Hearing

President Janzen opened the meeting for visitors to speak on a subject not on the Board Agenda.

Rhonda Pearce, 19972 Road 31, Madera – Kindergarten teacher at Alpha, spoke about the number of assessments that are required of teachers, class size reductions, and the substitute pool. Ms. Pearce also presented the Board with written information she compiled about number of assessments kindergarten teachers are required to do.

Kathryn Horn, 132 Deborah Way, Madera – Dixieland Teacher, spoke about class size reduction. Ms. Horn said thirty-three to one is just not realistic when you have so many children, on so many different learning levels.

Lane Cogdale, 2300 West Third, Madera – Mr. Cogdale began speaking about the transportation eliminations/reductions and Mr. Janzen had to interrupt him because this item is on the agenda, and the Public Hearing portion of the agenda is for items not listed on the agenda. Mr. Janzen explained it could be discussed during the correct portion of the agenda later in the meeting.

Miriam Singleton, 5173 West Bedford, Fresno – Cesar Chavez teacher, expressed to the Board that the teachers at Cesar Chavez, eighteen out of twenty-five were pink slipped, including herself. While they understand the effects of the State budget on school districts, they support their bargaining unit.

Suzanne Dudney, 14231 Road 35, Madera – Cesar Chavez teacher that was not pink slipped stated the difficulty of holding a school culture together when most of the teachers have been pink slipped. She supports her bargaining unit along with her fellow teachers at Cesar Chavez.

Greg Mazon, 18765 Avenue 17, Madera – Dixieland parent, wanted to express his opinion about the purchase of new computers for Board members that was approved at the April 27, 2010 Board meeting (Agenda Online Item). Mr. Mazon feels the Board should

purchase their own computers, not use District funds because the schools are in need of any additional funds.

Katherine Robertson, 1202 West Paul Street, Fresno – Dixieland teacher, just wanted to confirm that she could speak about Dixieland during the correct portion of the Agenda. Ms. Robertson requested that it be noted she wished to speak at the appropriate time.

Corky Walters, 1905 National, Madera – Mr. Walters wanted to verify that we had someone to translate for the Spanish speaking audience members. Arelis Garcia was present to do translation for the meeting.

Amanda Wade, 2323 Trevor Way, Madera – MUSD teacher, wanted to speak briefly to the Board regarding additional funds the District has discovered, and unconfirmed talk among staff about the District's priorities for using these funds. She was concerned that the unconfirmed priorities of the District did not include class size reduction. Ms. Wade made a verbal commitment to the Board, if they would in good faith, commit to class size reduction then they would commit at the table. Ms. Wade added he teachers will do their part in educating the students of Madera Unified, the reason we're all here.

Laura Toney, 3070 Easy Court, Madera – Parent and teacher of Madera Unified, spoke to the Board about a letter that was sent out by Superintendent Stafford regarding the State budget and the effect on Madera Unified. She wanted to know where the 30% cuts at the District Office were as stated in the letter. Ms. Toney expressed her concerns about class size reduction, grade level split classes, and the extreme importance of students reading skills by second grade.

Babette Jaire, 12333 Gabor Way, Madera – MUTA President, addressed the Board before Mr. Janzen had to close the Public Hearing portion of the agenda because the time limit had been exceeded. Ms. Jaire understood the time constraints and thanked the Board.

7B. Student and Staff Recognition

Chief Academic Officer, Darren Sylvia, had Madera High School Principal, Kent Albertson, and wrestling Coach Joe Romine join him at the podium to recognize exceptional student and athlete of Madera High School, James Cook, for winning the State Wrestling Championship. His stats speak for themselves; 42 and 2, 28 pins, with 27 of those in the first round. James was Madera High's Athlete of the Year and maintained a GPA of 3.5, all while making the following accomplishments: no losses in the State of California, maintained the #1 State ranking all season, 1430 ESPN Athlete of the Month, Buchanan Invitational Championship, Raul Huerta Invitational Championship, Conference Champion, Central Section Masters Champion, California State Champion, Amateur Wrestling News, Senior All American Team. James has recruiting visits to Arizona State, American University, Maryland University, and Oklahoma University. James is one of seven students in the history of Madera High School to win a State Championship.

9. Old Business

9A. Review cash flow and Third Interim Budget and potential effects on the proposed closure of Dixieland, elimination of high school transportation, and elimination of the Public Information Officer

Kelly Porterfield and Teri Bradshaw presented to the Board the effects reinstating these items from the reduction list would have on the projected budget and cash flow overview.

The summary of changes since the 2009/10 Second Interim are:

- Revenue Increase by 1.5 million dollars
- Expense Decrease by 1.3 million dollars
- Net Increase of 2.9 million dollars

Mr. Porterfield stressed that the budget is continually changing, and the projections need to be as accurate as possible to plan appropriately.

Clerk Garibay pointed out the fact that the District is continually borrowing money against funds that we know we'll receive to pay our debt. The reason for this is the State defers 25 percent of revenue until the following year. The upside to this is, the money borrowed earns interest and pays the finance costs associated with borrowing. The goal is that this is fiscally neutral. The District budget is a result of the State making permanent deferrals for funding of education. Cash flow is going to become a huge issue in the next few years and the District needs to be diligent in monitoring it.

Mr. Porterfield wanted the Board to understand the purpose of the presentation was to make them aware where we are in terms of cash flow and where we stand now as it pertains to taking items off the reduction list. The item of greatest concern to staff, because of timely decisions that need to be made, is Dixieland. To clarify, a question from the Board about sooner, rather than later, staff is recommending a decision needs to be made tonight regarding Dixieland.

The Board asked Mr. Porterfield and Ms. Bradshaw several clarifying questions before moving on the transportation issue.

Sam Armentrout, Director of Transportation and Security, and Jeff Smith, Operations Supervisor of Transportation, went through a PowerPoint presentation with options for transportation that were requested by the Board at the April 27, 2010 Board meeting.

The Board asked clarifying questions during the presentation.

Mr. Porterfield pointed out the high school transportation issue has the same concern to staff and the public as Dixieland, but for planning purposes, decisions can be made after the May revise.

Staff made the recommendation that efficiency options be looked at in regards to transportation and brought back after the May revise along with any other items on the reduction list that need consideration, with the exception of Dixieland, which needs to be decided by the Board tonight.

The Board was in agreement to bring transportation and the PIO back for discussion after the May revise.

Corky Walters, 1905 National, Madera – MUSD Parent, shares his concerns about the 3 mile radius for transportation proposed in tonight's presentation, and suggests a 2 mile radius, which is still extremely far for students carrying heavy backpacks.

Ana Mendoza, 1026 Don Miguel, Madera – MUSD Parent, requests to know what sacrifices the Board and administration have made to help the budget.

Jose Vallederos, 27410 Parkwood Avenue, Madera – Shares his concerns about planes that are spraying pesticides where children are walking to school if transportation is eliminated.
