NOTICE INVITING BIDS PURSUANT TO PUBLIC CONTRACT CODE 22000, ET SEQ.
(THE UNIFORM PUBLIC CONSTRUCTION COST ACCOUNTING ACT)

Notice is hereby given that the Madera Unified School District ("MUSD") will receive sealed bids for **Bid No.072723, New Walk-In Freezer at Child Nutrition**

EXAMINATION AND PROCUREMENT OF CONTRACT DOCUMENTS:

Contract Documents have been prepared by Mangini Associates Inc. Documents may be examined and obtained at the Architect's office, 4320 West Mineral King Avenue, Visalia, CA 93291, (559) 627-0530, Monday through Thursday between 8 am and 5 pm and Friday between 8 am and 12 pm or at Dodge Data & Analytics, Construction Bidboard (Ebidboard), Tulare-Kings County Builders Exchange (Visalia), the Central California Builders Exchange (Fresno), Kern County Builders Exchange (Bakersfield), Builders Exchange of Stockton.

Only bonafide **general contract bidders** may secure hard copies of the proposed Contract Documents from the Architect on the following basis:

- .1** Limited to 2 sets of specifications and drawings, upon payment of **\$150.00** deposit per set payable to Mangini Associates Inc., completely refundable if sets are returned to the Architect in good condition within 7 calendar days after bid opening.
- .2** A non-refundable charge of **\$20.00**, made by separate check, will be required for all sets requiring shipping and handling.
- .3** Additional complete sets may be purchased from the Architect at the price of 1.15 times the Architect's cost of reproduction and delivery.
- .4** Specifications and drawings will also be issued to various Builders Exchanges for subcontractors' use or subcontractors may purchase complete sets from the Architect at the price of 1.15 times the Architect's cost of reproduction and delivery. **Purchased sets are non-refundable.**
- .5** No partial sets or individual sheets will be issued or sold.
- .6** Only plan holders and the listed exchanges will be notified of Addenda.

To the extent required by Public Contract Code Section 20103.7, the District shall also make the Contract Documents available for review at one or more plan rooms

Pursuant to the provisions of Section 1770 et seq of the California Labor Code, each worker of the contractor and any of its subcontractors engaged in work on the Project shall be paid not less than the prevailing wage rate.

SB 854 established new public works contractor registration program requirements for all public works projects. Pursuant to Labor Code Section 1725.5; Starting March 1st, 2015 no contractor/subcontractor may be listed in a bid proposal unless registered with the Department of Industrial Relations (DIR). Starting April 1st, 2015 no contractor/subcontractor may be awarded a contract, nor employed on a Public Works project unless registered with the DIR. This project **is** subject to prevailing wage requirements and compliance monitoring and enforcement by the DIR and may at any time require contractors/subcontractors to upload electronic certified payroll records on the DIR website.

The Estimated Construction Cost for this project is \$2,000,000.00

Bidders shall be required to have a valid class “B” Contractor’s License.

Pre-Qualification Packet is due by Friday, August 18, 2023 @ 10:00:00 am. A copy of the Pre-Qualification Packet may be downloaded from Madera Unified School District Purchasing Department Website <https://www.madera.k12.ca.us/Page/6984>

Sealed Bids must be received by August 31, 2023 at MUSD Purchasing Department, 1205 Madera Avenue, Madera CA 93637 (located on the 2nd floor) no later than 2:00:00 pm.

Bids shall be accompanied by a certified check, cashier’s check , or bidders bond in an amount not less than ten (10%) percent of the total bids made payable to MUSD. The substitution of appropriate securities in lieu of retention amounts from progress payments in accordance with public Contract Code Section 22300 is permitted.
