NOTICE INVITING BIDS PURSUANT TO PUBLIC CONTRACT CODE 22000, ET SEQ.  
(THE UNIFORM PUBLIC CONSTRUCTION COST ACCOUNTING ACT)

Notice is hereby given that the Madera Unified School District ("MUSD") will receive sealed bids for **Bid No.031524-Asphalt Resurface & Repairs at Multiple Sites**

**A mandatory Job-Walk will be held March 22, 2024 @ 9:00 a.m. starting Desmond M.S.-26490 Martin Street, Madera Ca 93638, then to Pershing E.S.- 1505 E. Ellis St. then to Washington E.S.- 509 E. South St, then to, Lincoln E.S.- 650 Liberty Lane, then to Adams E.S.- 1822 National Ave, then to Parkwood E.S.-1150 E. Pecan, then to Chavez E.S.- 2600 E. Pecan and ending at MLK M.S.- 601 Lilly St.**

To the extent required by Public Contract Code Section 20103.7, the District shall also make the Contract Documents available for review at one or more plan rooms.

Pursuant to the provisions of Section 1770 et seq of the California Labor Code, each worker of the contractor and any of its subcontractors engaged in work on the Project shall be paid not less than the prevailing wage rate.

SB 854 established new public works contractor registration program requirements for all public works projects. Pursuant to Labor Code Section 1725.5; Starting March 1<sup>st</sup>, 2015 no contractor/subcontractor may be listed in a bid proposal unless registered with the Department of Industrial Relations (DIR). Starting April 1<sup>st</sup>, 2015 no contractor/subcontractor may be awarded a contract, nor employed on a Public Works project unless registered with the DIR. This project is subject to prevailing wage requirements and compliance monitoring and enforcement by the DIR and may at any time require contractors/subcontractors to upload electronic certified payroll records on the DIR website.

Bidders shall be required to have a valid class "A or C-12" Contractor's License.

**Sealed Bids must be received by April 2, 2024 at MUSD Purchasing Department, 1205 Madera Avenue, Madera CA 93637. (located on the 2<sup>nd</sup> floor) no later than 10:00:00**

**The Estimated Cost for this project is \$425,000.00**

Bids shall be accompanied by a certified check, cashier's check , or bidders bond in an amount not less than ten (10%) percent of the total bids made payable to MUSD. The substitution of appropriate securities in lieu of retention amounts from progress payments in accordance with public Contract Code Section 22300 is permitted.
