Pursuant to Labor Code Section 1725.5; Starting March 1st, 2015 no contractor/subcontractor may be listed in a bid proposal unless registered with the Department of Industrial Relations (DIR). Starting April 1st, 2015 no contractor/subcontractor may be awarded a contract, nor employed on a Public Works project unless registered with the DIR. This project is subject to prevailing wage requirements and compliance monitoring and enforcement by the DIR and may at any time require contractors/subcontractors to upload electronic certified payroll records on the DIR website.

Bidders shall be required to have a valid class "C7 and/or C10" License

This RFP will require a Job Specific Pre-Qualification Packet that will be due no later than May 5, 2021 @ 10:00 am. You may down load the pre-qualification packet from the Website.

The list of Pre-qualified vendors will be posted to the District Website no later than May 11, 2021. A mandatory Pre-RFP Conference will be held via Zoom May 14, 2021 @ 10:00 a.m. Those who qualified will be sent instructions on how to access the zoom meeting.
