- a. **CCSPP Grant Update** Ms. Munoz provided an update on the grant. Araceli Rodriguez is our Student Advocate and works in conjunction with staff and primarily with our counselor Mr. Adame. She provides interventions and support to students and families. Clarice Guzman asked about Tier 2 students. Are the parents contacted and what do they do? Mr. Macedo said that we do hold SST meetings. During these meetings, a lot of information is shared and through these meetings we are able to implement specific support needed.

- a. **NWEA** Ms. Munoz shared data from Fall NWEA assessment. Grades 1-6th math. It is an assessment given across the nation. They are compared to other students that are the same age as them but across the nation. Reading is given to grades 3-6 and Math in grades 1-6. The MET and EXCEEDING bands are meeting grade level expectations. Ms. Munoz students that came in this reviewed the data. The data for Fall 2023 was higher than Fall 2022. As a school, our students are growing and our staff is working hard to prepare the students. There is still a lot of room for improvement. Fall assessment was in August and the students are taking the winter assessment right now. It will show what the students have learned so far. Data will be reviewed to measure how the students are doing and determine next steps. In Math we are seeing growth but it is still a need. Teachers say that the students are taking the assessment seriously. The students are not rapid guessing. It is not an easy assessment. It is meant to be difficult. The computer will bump them up to the next level if that is what they need. Some students do get frustrated, but it is meant to push them and we can see how they are progressing.
- b. **PAC Update** Clarice Guzman is our PAC representative. She summarized the meeting was primarily about students needing additional help; more specifically Special Education students. They want to know what additional help the students can receive. She will continue to provide SSC PAC updates at our meetings.
