- i. **Local Assessment Data**

**Ms. Munoz reviewed SAP update. SAP update included:**

**Theory of Action--using aligned assessments to backwards map priority standards to plan rigorous lessons collaboratively and use assessment data to make instructional adjustments**

**NWEA Fall to Winter data analysis--3rd grade saw an increase in Reading and 3rd, 5th, and 6th grades saw an increase in Math. Schoolwide we went down in both slightly. BEST growth goal--Growth goal of 80% in Reading and Math by 2025. Current growth goal is 48% in Reading and 45% in Math. We are near our goal of 49% in Reading and 51% in Math.**

- 1. Each grade level team is linking their data by teacher and comparing what worked and didn't work for their students. This will help each team with the rigor of the curriculum.**
- 2. Celebrate - We are seeing students grow; however, not at the rate to meet grade level standards.**
- 3. Third administration of NWEA tests will be next week.**

**a. California Community School Participation Program (CCSPP)**

**CCSPP will provide a partnership between schools and community resources to offer a range of services and opportunities to children, youth, families, and communities. The grant will focus on supporting the social emotional learning of students/communities with the greatest need. Red pyramid received the grant for the 2022-23 school year and purple pyramid is applying for the grant for the 2023-24 school year. If the grant is awarded, we will propose to hire the following integrated student supports:**

- Student advocate at all elementary sites**
- Full-time counselor at K-8 sites**
- Intervention specialist at the secondary level**
- PE Teacher on Special Assignment to implement integrated SEL recess support at elementary schools**
- Behavior Intervention Technician for the purple pyramid**
- Behavior Analyst for the purple pyramid**
- Child Welfare & Attendance Liaison for the purple pyramid**
- Community Support Specialist for the purple pyramid**

**Funding would also be used to support family and community engagement, collaborative leadership & practices for educators, and extended learning time and opportunities. Funds will be based on enrollment; however, we will not get to spend it on whatever we want. SSC discussed the need for a Student Advocate to support monitoring attendance, academics, behavior and assist parents with trainings and referrals to outside agencies. The counselor does help with this but this would allow more students/families to receive this support.**

**b. PAC Update**

**Elsy Linez explained PAC approved the first three goals. They took parent input on how to spend the money and focus on how to help the students.**
