6. Board Workshop - District Academic Plan - Looking Ahead

Superintendent Lile, Assistant Superintendent of Educational Services, Sheryl Sisil and Executive Director of Accountability and Communications provided a presentation to the Board.

Superintendent Lile presented a draft version of the proposed Vision, Mission, Creed, Believe Statement and Core Values.

Superintendent Lile asked the Board for their feedback on what was being presented. Superintendent Lile presented a list of proposed names for this document.
