President Mendoza called the Public Session of the Board of Education to order at 5:15 p.m. President Mendoza opened the floor for public comment on any item listed in the Closed Session Agenda.

Amanda Wade, MUTA Vice President, Madera, expressed concerns with language in Resolution No. 28-2019/20 in regards to granting all authority to the Superintendent on future decisions for the district.

Michael Owens, Fresno, expressed concerns with employees working conditions.

Cheri Giddens, CSEA President, Fresno, stated CSEA had the same concerns as MUTA Vice President and requested the district works as a team with the unions.

There were approximately 275 visitors and District employees present online.

4. Request Adoption of Resolution No. 28-2019/20 regarding Extension Of School Closures And Delegating Authority To Superintendent To Take Necessary Actions In Response To Covid-19

Superintendent Lile presented the item to the Board. Superintendent Lile read a document that contained consensus language from Madera County Superintendents and from Madera County Superintendent of Schools, Dr. Cecilia Massetti in regard to extending the closure of schools to May 1st.

President Mendoza read a statement from the Board which addressed the importance for the superintendent to have the power and authority to make critical decisions in the months to come and in the event COVID-19 affects any Board members, or a quorum of Board members are not available to make these decisions. President Mendoza stated that decisions made must be in accordance with the law and with any directives issued by federal and state authorities. President Mendoza assured the actions contained in the resolution did not change the normalized operations of the district unless during a state of emergency where clear lines of authority could be interrupted. President Mendoza indicated the Governing Board will continue to monitor and guide the work of the district

on behalf of the community, staff and students and plans to remain engaged in their elected roles through this challenging period.

The trustees supported the statement of President Mendoza and the clauses included in the resolution.

President Mendoza opened the item for public comment.

Sarah Colomer, Madera, cited various government codes regarding collective bargaining, distant learning, directive language and MOU presented by MUTA.

Amanda Wade, Madera, MUTA Vice President, stated MUTA will continue protecting their members and collaborate with district administration.

David Holder, MUTA President, stated MUTA will be open to collaborative work with district administration.

Melissa Fuentes, Chowchilla, supported MUTAs position and asked their voices be heard.

Jackie Young, Fresno, supported a collaboration between MUTA and district administration.

Seeing no others come forward, President Mendoza closed public comment and brought the item back to the Board for questions and comments.

It was moved by Trustee Kennedy, seconded by Trustee Fleak, and unanimously carried to adopt Resolution No. 28-2019/20 regarding Extension Of School Closures And Delegating Authority To Superintendent To Take Necessary Actions In Response To Covid-19.
