Amanda Vela, CSEA President discussed that a member has requested clarification regarding how her initial salary step placement was determined and hopes that someone will get back to the member.

The Union has been getting questions from members that meet with Director Barreras, why Sandra Edwards attends these meetings.

Also, there are complaints about many of the clerical positions currently posted requiring Spanish bilingual skills. Ms. Vela would like to know if the District would be offering Spanish classes or trainings for their employees. She feels this is reverse discrimination.

7. NEW BUSINESS

A. Discuss and approve revised classified job description – Transportation Dispatcher

Director Barreras presented the revised job description, which includes requiring a bus driver certification for the Transportation Dispatcher.

Amanda Vela, CSEA President, stated that the Transportation Department is currently having many issues. The primary issues are with the contract language being broken and people are missing out on trips. She understands there is a shortage of bus drivers, but the dispatchers should be dispatching buses, not out driving. There is already a shortage of office staff because most of the staff is out driving buses except for the Administration Assistant. She would like the District to work on more incentives to recruit School Bus Drivers.

Director Barreras responded that some of the issues President Vela discussed are working conditions and should be discussed with the District and not the Personnel Commission. Director Barreras also pointed out that the job description has included as part of the essential functions where it states that the transportation dispatcher covers for ill drivers or breakdowns, for the purpose of ensuring completion of transportation routes in a timely manner.

Kent Albertson, Chief Human Resources Officer, stated the District is fully staffed with School Bus Drivers. The issue is not the recruitment of School Bus Drivers. but an attendance problem. On a Friday, there could be 25 Bus Drivers absent. Other Districts do require their Dispatchers to have a School Bus Driver certification.
